

**Expedition to Biblical Jordan and Egypt 2019**  
***ASSUMPTION OF RISK & HOLD HARMLESS AGREEMENT***

1. In consideration for participation in the tour Expedition to Biblical Jordan and Egypt, I hereby release Gospel Travel and the tour directors of Timeless Tours, other related entities, their officers, agents, servants, volunteers, or employees (hereinafter referred to as releasees) from any and all liability, claims, demands, actions, and causes of actions whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of the property belonging to me, whether caused by the negligence of the releasees, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted; and further waive, discharge, and covenant not to sue the said releasees.
2. I am fully aware of the risks involved and hazards connected with any activities undertaken while participating in the tour Expedition to Biblical Jordan and Egypt, including, but not limited to, navigating uneven, steep terrain, and various other environments; tripping, falling, minor cuts, scrapes, bruises, and other incidents; damage to clothing, footwear, and other personal effects; and serious personal injury and/or death, and I hereby elect to voluntarily participate in said activity with full knowledge that said activity may be hazardous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged in such an activity, whether caused by negligence of releasees or otherwise.
3. I am fully aware of the risks involved with traveling to the Middle East and understand that the tour directors reserve the right to change the itinerary, delete or substitute sites when they feel it to be in the best interest of the tour. Furthermore, Gospel Travel and the tour directors of Timeless Tours are not responsible for delay, accident, sickness, loss of personal property, strikes, armed conflict, additional expenses due to weather, disruption of advertised schedules, refusal of visas, or any other causes beyond their control. The releasees are also not responsible for war, terror or acts of God. Furthermore, the operation of the vehicles used in their tours is the full responsibility of the companies and individuals engaged in the conveying of passengers; said companies or individuals are governed by laws of the country of operations and recourse for any mishap must be filed locally.
4. I hereby agree that the releasees reserve the right to limit my involvement in any tour or activity at any time for any reason that may jeopardize my safety or the safety of other tour participants or the releasees, and that participation in the tour Expedition to Biblical Jordan and Egypt not qualify me as trained for any unsupervised exploration, climbing, or other activity for which I acknowledge that further instruction is required. I further agree that I will wear appropriate footwear, clothing, sun protection, and other safety equipment deemed necessary by releasees at all times during the tour.
5. I further hereby agree to indemnify and hold harmless the releasees from any loss, liability, damage, or costs, including court costs and attorney fees, that they may incur due to my participation in said activity, whether caused by negligence of releasees or otherwise.
6. It is my express intent that this Assumption of Risk and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a release, waiver, discharge, and covenant not to sue the above-named releasees. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the states of North Carolina and Michigan.
7. In signing this release, I acknowledge and represent that I have read the foregoing Assumption of Risk and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent, that I am not knowingly pregnant; and I execute this release for full adequate and complete consideration fully intending to be bound by the same. Recognizing that not every risk can be listed above, by signing my name(s) below and participating in the tour Expedition to Biblical Jordan and Egypt I voluntarily assume any and all risks (whether or not listed) associated with Gospel Travel and the tour directors of Timeless Tours and I specifically agree to hold harmless Gospel Travel and Timeless Tours tour directors Robert Bates and Stefanie Elkins. That is, I agree to assume responsibility for any injuries and damages I might suffer and not seek compensation from the above mentioned entity and persons.
